- A copy of the updated Crypto Mining Ordinance is included in your packet for review and is on the agenda for action.
- HB 489 known as the Service Delivery Strategy Act was passed in 1997 to help local governments in Georgia work together to provide services to citizens in an efficient cost effective way, to eliminate duplication of services and double taxation. The act required counties and municipalities to reach agreements on how services are provided. These agreements, known as 489 or Service Delivery Agreements are typically adopted for periods of ten years and require renewal at their expiration. The agreement between Gilmer County, Ellijay and East Ellijay due for renewal. The Gilmer County Commission adopted a resolution this week extending the current agreement for five years. The cities of Ellijay and East Ellijay are also required to adopt the resolution. A copy of the resolution along with the current agreement is included in your packet for review and is on the agenda for action.
- Per previous discussion and request, a speed study has been completed for North Main Street. A resolution and ordinance to amend maximum speeds on North Main is included in your packet for review and is on the agenda for first reading.

AN ORDINANCE TO AMEND ZONING

A RESOLUTION AND ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF ELLIJAY, GEORGIA, IN ORDER TO AMEND APPENDIX A FOR THE PURPOSES OF AMENDING THE ZONING PROCEDURES PROVISIONS IN ORDER TO BETTER PROTECT AND IMPROVE THE PUBLIC HEALTH, SAFETY AND WELFARE OF THE CITIZENS OF THE CITY OF ELLIJAY, GEORGIA.

WHEREAS, the duly elected governing authority of the City of Ellijay, Georgia is authorized under Article 9, Section 2, Paragraph 3 of the Constitution of the State of Georgia to adopt reasonable ordinances to protect and improve the public health, safety, welfare and aesthetics of the citizens of the City of Ellijay, Georgia; and,

WHEREAS, The Mayor and Council of the City of Ellijay have previously adopted the Code of Ordinances, City of Ellijay, Georgia; and,

WHEREAS, the City of Ellijay desires to amend its Code of Ordinances to amend the Zoning ordinances as it relates to provisions on certain changes to the procedures in order to address the current trends in crypto-currency and data mining;

WHEREAS, it is requisite and proper for the security, welfare, health, and safety of the citizens of the City of Ellijay, Georgia, that the following provisions be adopted and authorized; and,

WHEREAS, the Mayor and Council of the City of Ellijay wish to modify and amend the Code of Ordinances;

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED by the City Council of Ellijay, Georgia, and the council of the City of Ellijay hereby ordains that:

SECTION 1

Article 20 shall be created in Appendix A-Zoning, of the Code of Ordinances of the City of Ellijay, Georgia shall be amended and the following shall be added:

Sec. 20-1. – Purpose.

To establish standards relating to cryptocurrency and data mining in order to protect the public health, safety, and welfare, while avoiding unintended impacts on resources and adjacent

uses, while enabling the development of Cryptocurrency Mining and Data Centers, to the extent possible, in areas where any potential adverse effects on the community will be minimized.

Sec. 20-2. – Definitions.

Code Enforcement Officer. Any person contracted with or employed by a state, county, or municipality who has enforcement authority for health, safety, or welfare requirements and is authorized to issue citations or file formal complaints regarding the same as contemplated by O.C.G.A. § 36-74-21(1).

Cryptocurrency. A digital currency in which encryption techniques are used to regulate the generation of units of currency and to verify the transfer of funds while operating independently of a central bank.

Cryptocurrency Data Center. Leased or owned boundaries of floor space devoted to the operating data processing equipment for Commercial Cryptocurrency Mining; excludes spaces for data centers not otherwise engaged in commercial cryptocurrency mining, commercial offices, storage, shipping and receiving, warehousing, or any other space that is not electronic processing.

Commercial Cryptocurrency Mining. The commercial process by which cryptocurrency transactions are verified and added to the public ledger, known as the block chain, and also the means through which new units of cryptocurrencies are released through the use of server farms. Any equipment requiring a High-Density Load Service, for the purpose of operating a cryptocurrency mining server farm will constitute a commercial cryptocurrency mining operating.

Cryptocurrency Server Farm. Three or more interconnected computers housed together in a single facility whose primary function is to perform cryptocurrency mining or associated data processing.

Data mining. The commercial process by which volumes of data are analyzed to find patterns, discover trends, and gain insight into how the data can be used will constitute a commercia data mining operating.

High-density Load Service. Any individual service at or above 600 amps in which the Energy Use Intensity (EUI) is calculated as greater than 250kWh/feet2/year in total for all operating square feet.

Manufacturing. Manufacturing means the converting of raw, unfinished materials or products, or any or either of them, into an article or articles or substance of a different character, or for use for a different character, or for use as a different purpose. Manufacturing does not include Cryptocurrency Mining, Farming or Data mining.

Office. A building, or portion thereof, wherein a predominately administrative, professional, or clerical operations are performed, and not involving retail sales or Cryptocurrency Mining, Farming or Data mining.

Recycling Center. Any facility utilized for the purpose of collecting, sorting and processing materials to be recycled, including but not limited to, plastics, glass, papers and aluminum materials and not involving or related to Cryptocurrency Mining, Farming, or Data mining.

SOC 2. A voluntary compliance standard for service organizations, developed by the American Institute of CPAs (AICPA), which specifies how organizations should manage customer data. The

standard is based on the following Trust Services Criteria: security, availability, processing integrity, confidentiality, and privacy.

Sec. 20-3. – Applicability and Location.

- 20-3.1. This ordinance shall apply to all commercial cryptocurrency mining and data mining operations installed, constructed, or modified after the effective date of this Ordinance.
- 20-3.2. All commercial cryptocurrency and data mining operations shall be designed, erected, and installed following all applicable Local, State and Federal codes, regulations and standards.
- 20-3.3. Commercial Cryptocurrency Mining, a Cryptocurrency Data Center and a Cryptocurrency Server Farm shall only be located and conducted on property zoned I-2 (Crypto-currency/Data Mining) within the City limits and only after the application for, and the grant of, conditional use permit by the Mayor and City Council. Within said I-2, part of the conditional use permit will require the following setbacks: 200 feet front, 200 feet sides, 200 feet rear. It may not be located within a flood plain within the City limits.
 - Sec. 20-4. Standards for Commercial Cryptocurrency Mining Operations.
- 20-4.1. All principal and accessory structures used for cryptocurrency mining operations, server farms, and/or data mining centers, shall be arranged, designed, and constructed to be harmonious and compatible with the site and with the surrounding properties. If prefabricated, pre-engineered or modular structures are installed, the following standards are required:
 - a. All structures shall have concrete foundations.
 - b. All exterior facades shall have muted earth tone colors, and shall not be defective, decayed, or corroded.
 - c. If intermodal shipping containers are utilized, such installations shall comply with the requirements of the most recent edition of the Industrialized Building Rules and Bulletins of the Georgia Department of Community Affairs, and O.C.G.A Title 8, Chapter 2, Article 2. Part 1.
- 20-4.2. The operators shall not cause, allow, or permit the operation of any source of sound which creates at an occupied residential building or defined sensitive receiver, as may exist at the time of the issuance of a certificate of completion or occupancy, a sound level that exceeds a daytime continuous sound level of 50dBA or a nighttime continuous sound level of 45dBA.
- 20-4.3. The operators shall not cause, allow, or permit the operation of any source of sound or vibration which creates a pure tone where the one-third (1/3) octave band sound pressure level in the band of interest exceeds the arithmetic average of the sound-pressure levels for the two adjacent one-third (1/3) octave bands by the corresponding decibel (dB(Flat)) values as follows:
 - a. 5dB for center frequencies of 500 Hertz and above;
 - b. 8dB for center frequencies between and including 160 and 400 Hertz; and
 - c. 15dB for center frequencies less than or equal to 125 Hertz.
 - d. A pure tone shall be deemed present by measurement.

- 20-4.4. For permitting and compliance purposes, measurements shall be performed using a calibrated Type 1 Sound Level Meter, configuring to log and record one-third (1/3) octave flat-weighted equivalent sound pressure levels, and A-weighted equivalent level (Leq), slow time weighting, with a 15-minute averaging interval. Measurements shall be made proximate to, but no closer than 100 feet from any adjacent property line. Transient background sounds must be excluded from the measurement period by post-processing or other means. Compliance is indicated if the noise solely generated by the operator cannot be discriminated from the equivalent-continuous background sound pressure level, or if the noise levels solely generated by the operator otherwise conform to the requirements of Section 20-4.3 and 20-4.4.
- 20-4.5. Prior to the issuance of a certificate of completion or occupancy, a report with noise level test results shall be submitted for approval by the applicant from a noise control engineering professional for the purpose of demonstrating compliance. The expense for testing and reporting the results, in written format, to the City will be the responsibility of the applicant.
- 20-4.6. A noise reduction barrier or device may be required at the discretion of the City when it is conclusive that noise level tests do not conform to Section 20-4.3 and 20-4.4. If this is required of the applicant of facility, the expense of compliance shall be the applicant's and not the City's.
- 20-4.7. Terminology as used herein related acoustic levels and measurements follow American National Standard ANSI S12:9: "Quantities and Procedures for Description and Measurement of Environmental Sound Part 1: Basic Quantities and Definitions," and ANSI S12:9: "Quantities and Procedures for Description and Measurement of Environmental Sound. Part 3: Short-term measurements with an observer present".
- 20-4.8. All servers, computers, processors, materials, and equipment must be enclosed within buildings. These buildings will be subject to commercial design standards.
- 20-4.9. The equipment used in any Commercial Cryptocurrency Mining operation shall be housed in a metered (either individually or collectively in primary-metered services), electrically grounded, and pre-engineered metal-encased structure with a fire rating designed to resist an internal electrical fire for at least 30 minutes. The containment space shall contain baffles that will automatically close in the event of fire independent of a possible electric system failure.
- 20-4.10. Prior to issuance of a building permit, the applicant shall provide written verification from the power provider (Georgia Power or Amicalola EMC) that the applicant has calculated the maximum potential electrical consumption of the proposed use and has verified the utility supply equipment and related electrical infrastructure is sufficiently sized and can safely accommodate the proposed use during power provider's peak consumption hours.
- 20-4.11. Power shall only be provided by either Georgia Power or Amicalola EMC. No use of alternative power, such as wind, or hydro, is permitted, whether on-site or off-site. Solar panels, however, may be used as an alternative source of power.
- 20-4.12. Commercial Cryptocurrency Mining Data Center will undergo SOC 2 auditing resulting in successful certification. The data center will also maintain the SOC 2 certification for the duration of operation. Validation of certification will be provided to the City within 13 months of beginning operating and annually thereafter.
- 20-4.13. Any use or activity producing air, dust, smoke, glare, exhaust, heat, or humidity in any form shall be carried on in such a manner that it is not perceptible at or beyond the property line.

- 20-4.14. Any use of ISO shipping containers or similar as housing, whether horizontally combine or independent of other structures for the commercial cryptocurrency mining operation, shall not be vertically combined to exceed a height of greater than nine (9) feet.
- 20-4.15. A security fence with a minimum height of eight (8) feet must be installed around the perimeter of the server farm building. Each commercial cryptocurrency mining and data operation shall provide a 24-hour emergency contact signage visible at the access entrance. Signs shall include company name if applicable, owner/representative name, telephone number, and corresponding local power company and telephone number.
- 20-4.16. No façade of any commercial cryptocurrency mining operation shall have more than twenty (20%) percent of the area exposed with apparatus (e.g., vents, fans, HVAC systems, etc.).
- 20-4.17. An active clean agent fire protection system must be provided and maintained in good working order within any structure which contains a server farm. High sensitivity smoke detectors shall be installed and operational in order to activate the clean agent fire suppression system.
- 20-4.18. There shall be an emergency electrical termination switch installed outside of any containment structure which contains the server farm. The switch shall be appropriately signed so that responding public safety officials can quickly identify it.
- 20-4.19. All building requirements in this section, including but not limited to heat transfer apparatuses, fire detection/suppression systems, or containment structures shall be designed by a State of Georgia licensed engineer and in accordance with all applicable codes and standards.
- 20-4.20. Prior to issuance of a building permit, the applicant shall provide written verification of a waste management plan for any waste water and/or other technology waste products.
- 20-4.21. The ambient temperature inside of a containment space which houses a server farm shall not exceed 120 degrees Fahrenheit at any time. No person shall be permitted to regularly inspect and work within the containment area which houses a server farm if the ambient temperature within the containment areas exceeds 90 degrees Fahrenheit.
- 20-4.22. Any Server Farm shall ensure that no more than twenty (20%) percent of the heat dissipated by the mining activity shall be released directly to the outside when the average daily temperature is less than 40 degrees Fahrenheit.
- 20-4.23. All requirements of Section 20-4 must be maintained after the issuance of a certificate of occupancy. Any violation of such will be handled in accordance with Section 20-6.

Sec. 20-5. – Application and Approval.

No commercial cryptocurrency or data mining operation may be developed without site plan review and verification by the City that all requirements within this ordinance are met.

Sec. 20-6. - Violations.

20-6.1. Any section of this ordinance that is not followed constitutes a violation of the same. Each incident is a separate violation such that multiple violations may occur on the same date and subsequent dates.

- 20-6.2. The Code Enforcement Officer or any City police officer has the discretion to issue a warning or a citation on a case-by-case basis.
- 20-6.3. Any violation shall have a maximum punishment not to exceed a fine of \$1,000.00, imprisonment for 60 days, or both.
 - Sec. 20-7. Effectiveness, Interpretation, Separability.
- 20-7.1. This Article shall become effective immediately upon its adoption.
- 20-7.2. All Ordinances, or parts of Ordinances, in conflict herewith are replaced.
- 20-7.3. If any part of this Ordinance conflicts with any other applicable federal, state, or local regulation, the more restrictive regulation shall control.
- 20-7.4. If any section, clause, portion or provision of this Ordinance is found unconstitutional, such invalidity shall not affect any other portion of this Ordinance.

SECTION 2

The sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared illegal by the valid judgment or decree of any court of competent jurisdiction, such illegality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this Ordinance.

SECTION 3

Penalties for a violation of current Code of Ordinances sections applicable to the amendment described herein in effect upon the adoption date of this ordinance are adopted herein as if completely set out herein.

SECTION 4

All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.

SECTION 5

Nothing in this ordinance or in the ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as city in Section 4 herein; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

AMENDMENT TO CODE OF ORDINANCES

CITY OF ELLIJAY GEORGIA

A RESOLUTION AND ORDINANCE TO AMEND, ESTABLISH, AND ALTER MAXIMUM SPEED LIMITS UPON NORTH MAIN STREET WITHIN THE CITY OF ELLIJAY, GEORGIA; TO PROVIDE RULES AND REGULATIONS THEREFOR; AND FOR OTHER PURPOSES.

WHEREAS, the duly elected governing authority of the City of Ellijay, Georgia is authorized under Article 9, Section 2, Paragraph 3 of the Constitution of the State of Georgia to adopt reasonable ordinances to protect and improve the public health, safety, welfare and aesthetics of the citizens of the City of Ellijay, Georgia; and,

WHEREAS, Title 40 Chapter 6 Article 9 §40-6-183 allows that "whenever the governing authority of an incorporated municipality, it its respective jurisdiction, determines on the basis of an engineering and traffic investigation that the maximum vehicle speed permitted under Chapter 6 of Title 40 is greater than is reasonable and safe under the conditions found to exist upon a highway or part of a highway under its jurisdiction, such authority may determine and declare a reasonable and safe maximum vehicle speed limit which decreases the limit within an urban or residential district, but not to less than 25 miles per hour or which decreases any speed limit where a special hazard or condition exists that requires a lower speed for compliance with Code Section §40-6-180"; and,

WHEREAS, W&A Engineering conducted an Engineering and Traffic Investigation (ETI) for the 2.40 mile section of North Main Street (Old Highway 5) from Church Street to State Route 515 / US 76. and,

WHEREAS, the City Council and Mayor, has determined on the basis of the engineering and traffic investigation performed by W&A Engineering, submitted on August 14, 2024, that the maximum speeds as set by Title 40 of the Official Code of Georgia are greater than is reasonable and safe under the conditions found to exist on North Main Street from Church Street to State Route 515 / US 76; and,

WHEREAS, the City previously adopted, by resolution and ordinances, speed zones for the roadways and streets within the city; and,

WHEREAS, the council finds the previously established and current maximum speed limit from 0.12 mile south of CS 527 Spring Street to 0.02 mile south of CS 542 Parks Ave. is appropriate to current conditions and circumstances; and,

WHEREAS, it is requisite and proper for the security, welfare, health, and safety of the citizens of the City of Ellijay, Georgia, that provisions regarding maximum speed limits for vehicular traffic upon the city's roadways be appropriately established by the local governing authority; and,

WHEREAS, the Mayor and Council of the City of Ellijay wish to modify and amend the Code of Ordinances,

NOW, THEREFORE, BE IT RESOLVED AND ORDAINED by the City Council of Ellijay, Georgia and the council of the City of Ellijay that:

SECTION 1

The Code of Ordinances of the City of Ellijay, Georgia shall be amended by adopting the maximum speed limit upon North Main Street / Old Highway 5 from 0.12 mile south of Spring Street to State Route 515 / US 76 as follows:

From the intersection of South Main and Spring Street to 0.17 mile south of Parks Avenue the maximum speed limit shall be 25 miles per hour.

From 0.17 mile south of Parks Avenue to 0.26 mile south of CR1 Call-Wright Road the maximum speed limit shall be 35 miles per hour.

From 0.26 mile south of CR1 Call-Wright Road to State Route 515 / US 76 the maximum speed limit shall be 45 miles per hour.

SECTION 2

The previously approved list of maximum speed limits for the City of Ellijay's list of Off-System roads (as filed with the Georgia Department of Public Safety) is, for purpose of convenience and future planning, reiterated herein by reference with the changes in Section 1 inserted and referenced in **bold** font.

All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed.



Location:

N. Main Street/Old Hwy 5 is located in the City of Ellijay. It extends from the Square to SR 515, for a length of approximately 2.40 miles.

Roadway Characteristics:

N Main Street/Old Hwy 5 extends south to north and is a two-lane roadway that is functionally classified as a Major Collector. N Main Street/Old Hwy 5 has 12' wide travel lanes with narrow rural grassed shoulders. The following images illustrate typical segments in the corridor:



Roadway Development:

N Main Street/Old Hwy 5 is old State Route 5 that was removed from the State Route system in the 1980's. The segment of this evaluation extends from downtown Ellijay, which is developed, quickly transitioning into very rural characteristics. It is dotted with numerous businesses closer to town, transitioning to single-family residences in the rural segment. It should be noted that open frontage is prevalent in the corridor with very little access control.

Crashes:

Crash data for Segment 1-0.02 miles south of N. Church Street to 0.17 miles south of Parks Street was obtained for a three-year period from August 1, 2022 to July 31, 2024 from the Georgia Electronic Crash Reporting System (GEARS). There was a total of twelve (12) crashes for the three period.

USLIMITS2:

The Federal Highway Administration (FHWA), in partnership with the National Cooperative Highway Research Program (NCHRP), created the USLIMITS2 tool. This tool is designed to help engineers set reasonable, safe and consistent speed limits.

For Segment 1, USLIMITS2 determined that the existing crash rate was above the critical rate. Thus, it recommends a posted speed limit of 20 MPH. The USLIMITS2 report is included in the appendix.

For Segment 3, USLIMITS2 determined that the existing crash and injury rate are below the critical rate. Thus, it recommends a posted speed limit of 40 MPH. The USLIMITS2 report is included in the appendix.

Existing Traffic Control:

The posted speed limit along the corridor starts at 25 MPH, stepping up to 55 MPH north of the City of Ellijay. The 25 MPH zone starts at 0.12 miles south of CS 527/Spring Street and extends to 0.02 miles south of CS 530/Church Street. The 35 MPH zone starts at CS 530/Church Street and extends to 0.17 miles south of CS 542/Parks Avenue. The 45 MPH zone starts at 0.17 miles south of CS 542/Parks Avenue to 0.26 miles south of CR 1/Call Wright Road. Lastly, the 55 MPH zone starts at 0.26 miles south of CR 1/Call Wright Road and extends to SR 515.

All intersecting roadways operate as a conventional (minor street) stop condition.



Recommendations:

It is important to note that the speed limits were not evaluated or considered for revision once the roadway was removed from the State Route system. The operational characteristics and function of the roadway no longer support the regional nature of traffic. This corridor is primarily intended to serve local users on the north side of the City of Ellijay. In addition, it allows greater flexibility for the Gilmer County School System via House Bill 1284 "Addy's Law" that went into effect July 1, 2024. This law created a new section in Part 5 of Article 22 of Chapter 2 of Title 20 of the Official Code of Georgia Annotated relating to school buses for elementary and secondary education. Now, in establishing routes for school buses, "public school systems shall consider routes that do not have stops requiring a student entering the school but to cross a roadway with a speed limit of 40 miles per hour or greater." Ellijay Elementary School is one of only three elementary schools in the county and having the flexibility in routing school buses safely and efficiently is critical.

<u>Segment 1</u> - 25 MPH zone from 0.02 miles south of CS 530/N. Church Street to 0.17 miles south of CS 542/Parks Avenue.

<u>Segment 2 - 35 MPH</u> zone 0.17 miles south of CS 542/Parks Avenue to 0.26 miles south of CR 1/Call Wright Road.

Segment 3 - 45 MPH zone 0.26 miles south of CR 1/Call Wright Road to SR 515.

Note that Segment 2 was not evaluated with USLIMITS2 but was identified as the natural stepup from Segment 1 (25 MPH) to Segment 3 (45 MPH). It is further noted that these locations retain the existing speed limit transition points which will retain driver expectations are they are familiar with speed limit changes at these points.
